SEALED BIDS for construction of Maple Ave (CR 1450) Water Line Replacement for the City of Caney, Kansas will be received by the City of Caney, Kansas until 10:00 A.M., Wednesday, July 26, 2023, at Caney City Hall, 100 W. 4th Street, Caney, KS 67333.

The bids will be opened and reviewed publicly by representatives of the Owner. Bidders will be advised of the outcome of the bidding process after all bids are fully evaluated by the Owner.

The work to be performed under this contract generally consists of the replacement of approximately 732 L.F. of 12" diameter DI water line with 12" diameter HDPE water line, including 640 L.F. of pipe bursting and appurtenances for a complete and in-service water line.
