## **BUSINESS:**

- 1. Discussion of Current Water Event: City Administrator Gress discussed the situation concerning the discoloration of the water. Has been working with KRWA and KDHE. It is felt that there are a couple of factors causing the situation. A line that broke at the water plant that feeds the permanganate to the water and the drilling that Atmos is doing to replace their gas lines. They are working on trying to resolve and will keep council updated. No Action Taken
- 2. Discussion of Revenue Neutral Rate Intent: The budget is still in progress and working to keep mill down. No Action Taken
- 3. Cereal Malt Beverage License for Special Event: The Caney Saddle Club has made application for a temporary permit for the Bull Riding Event that will be on September 11, 2021 at the Caney Recreation Sports Complex. Motion was made by Rogers; seconded by Wood to approve request. 7-0 Motion Carried
- 4. Proposed Resolution: RESOLUTION OF THE CITY OF CANEY, KANSAS APPROVING A TEMPORARY PERMIT ALLOWING FOR THE CONSUMPTION OF CEREAL MALT BEVERAGES AT THE CANEY RECREATION SPORTS COMPLEX; SADDLE CLUB ARENA FOR THE BULL RIDING EVENT. Motion was made by Rogers; seconded by Wood to pass.
