- 7. Appointment of Councilmember to Vacant Ward: Received two applications: (1) Kenith Butts; (2) Jeremy Berry. Motion was made by Rogers; seconded by Ranes to appoint Kenith Butts to fill the vacant Ward. 6-0 Motion Carried
- 8. Review of Fire Department Election of Officers: Fire Department Volunteers re-elected Nick Wood as the Fire Chief, Motion was made by Johnston; seconded by Wood to accept the nomination. 7-0 Motion Carried
- 9. Consider Allowing Police Department to Convert Executive Session Room into an Interview Room: Chief Kitterman presented the idea to council. Will build a wall, sound proof the room and install a door. The employees would do the work. Motion was made by Johnston; seconded by Butts to approve the request. 7-0 Motion Carried
- 10. Request Permission to Make Changes to City Bank Account: City Clerk would like to start the process of putting Josh Elliott on Bank Records (Signature Cards) and remove Mayor Burk effective January 3rd, 2022. This will allow the bank to start working on getting the paperwork together so that there will not be a big delay in getting checks signed in a timely fashion. The city has payroll and payables to run the first week in January. Motion was made by Butts; seconded by Wood to approve request. 7-0 Motion Carried
